- 6. 2018 operating plans and priorities
 - a. brushing –Dot night funding received. This work will be once again completed by Wildhorse Forestry. Enough funding for three rounds of brushing at the Ski Hill and one round of brushing at Delaurentiis.
 - b. Paid trail crew crew of 3 (manager and two general crew) 4 weeks of time split roughly as 1 week maintenance, 3 weeks new construction

- c. Production of new trails maps has been identified as a priority. All maps printed last year were picked up within a few months. Want to make a slightly better product. Possibility of seeking advertising or funding grant to help cover costs. Garry Quist can support with graphic design.
- d. trail layout -
 - Delaurentiis extension Trail layout past existing trail end up towards mountain top. Peter Tchir indicated interest in being involved in this layout
 - ii. Salmo Ski hill Layout of top to bottom intermediate bike trail and layout of additional hiking loop/connection
 - 1. Mike van Wijk indicated interest in being involved in hiking trail
 - 2. Stefan Jones indicated interest in being involved in intermediate bike trail
 - iii. Erie Park and connections longer term objective but good opportunity to connect from town. More challenging to connect across creek to ski hill.
 - iv. Bonnington Traverse Lisa continuing to work on layout and feasibility plan with Doug Clarke from Kootenay
 Mountaineering Club. Plan is to do a through hike this year.
 Amy mentioned Lee Usher motocross group might be looking into similar trail. Lisa to follow up.
 - v. Blood, sweat and beers Jill, new exit will be constructed on their property and land access agreement sign with Vaagen Fibre who now owns the adjacent forest land. May need to look into parking options in future depending on popularity of trail
 - vi. Panther Lake last year Tyler Dutton asked about possibility of hardening campsites and adding bear cache or pole. Good opportunities in this area for trail upgrades to lake, improving trail past lake to ridge and campsite hardening. Kootenay Mountaineering Club also interested so possible future partnership project.
 - vii. Suggestion by Jill of potential for trail down the Champion Lakes draw out to highway. Long-term possibility.
- e. fundraising events
 - i. Consider the Curling Rink for a fall party. Nothing to formal or organized just music, maybe live bands, cover fee. Curling Club runs bar and liquor license

7. Other business

- a. Trail application updates
 - i. Quartz Creek. Lisa Tedesco had a discussion with Recreation Sites and Trails and application is still in referral process as they are backed up with processing files. BCTS has indicated no significant concerns and this would have been the most likely barrier so should be a straight forward referral.

- ii. True blue inducer. Similar to Quartz, still in referral process. Given location unlikely to be any issues.
- iii. Erie Park nature trail. Lay out complete but final approval still with BC Parks. Not a big priority for them.
